EXAMPLE COMMISSION CALCULATION (₹4,999 SALE PRICE, 70% COMMISSION RATE)

- CALCULATE COMMISSION (INCL. GST)

Formula:

$$\text{Commission (Incl. GST)} = \text{Sale Amount} \times (\text{Commission Rate} \div 100)$$

$$9,999 \times 70\% = ₹6,999.3$$

- REMOVE GST FROM COMMISSION

Formula:

$$\text{Commission (Excl. GST)} = \text{Commission (Incl. GST)} \div (1 + \text{GST Rate} \div 100)$$

$$₹6,999.3 \div 1.18 = ₹5,931.61$$

- DEDUCT TDS (2%)

Formula:

$$\text{Actual Commission (After TDS)} = \text{Commission (Excl. GST)} \times (1 - \text{TDS Rate} \div 100)$$

$$₹5,931.61 \times 0.98 = ₹5,812.98$$

FINAL EARNINGS SUMMARY:




